

Reporting Requirement “Cheat Sheet” for Working with Minors

<u>Title IX</u>	<u>Clery Act</u>	<u>Abuse/Neglect of Minor</u>
<p>Discrimination based on age, color, disability, sex (including pregnancy), gender, gender identity, gender expression, genetic information, national origin, political affiliation, race, religion, sexual orientation, or veteran status.</p> <p>Any of the following:</p> <ul style="list-style-type: none"> • “This for That” sexual requests • Persistent, unwanted sexual advances • Severe, objectively offensive sexual behavior to make a reasonable person want to leave a program, event or activity • Sexual Assault • Stalking • Rape <p><u>Who to Notify:</u></p> <p>Program Administrator VA Tech Title IX Coordinator Local Police (for bold incidents in list) Youth Protection Office</p>	<p>Offenses below on or close to university property:</p> <ul style="list-style-type: none"> • Homicide: murder and non-negligent manslaughter • Negligent manslaughter • Robbery • Aggravated Assault • Burglary • Motor Vehicle Theft • Arson • Liquor Law Violation (does not apply to public intoxication or DUI) • Drug Law Violation • Weapon Law Violation • Hate Crime • Larceny-Theft • Simple Assault • Intimidation • Property Damage • Domestic Violence • Dating Violence • Stalking Incidents • Sexual Assault • Rape <p><u>Who to Notify:</u></p> <p>Program Administrator VA Tech Title IX Coordinator (for bold incidents in list) Local Police Youth Protection Office</p>	<p>By parent, guardian or any custodial relationship.</p> <p>Possible Signs of Abuse:</p> <ul style="list-style-type: none"> • Unexplainable injury • Burn marks • Bruising • Fear of parents • Withdraws or “shrinks” with adult presence <p>Possible Signs of Neglect:</p> <ul style="list-style-type: none"> • Begg or steals food or money • Lacks needed medical or dental care, immunizations, or glasses • Is consistently dirty and has severe body odor • Lacks sufficient clothing for the weather • Abuses alcohol or other drugs • States that there is no one at home to provide care <p><u>Who to Notify:</u></p> <p>Program Administrator Local Police if any immediate danger exists Local Office of Social Services Youth Protection Office</p>
